1. The student will receive 10 hours of classroom training and 6 hours of behind the wheel training. **Student must complete all 6 hours of behind the wheel training to receive completion certificate.** A fee of \$10 will be charged for replacement of lost certificates.
 2. Tuition for the complete course of driver training is \$375. **Tuition must be paid in full upon scheduling driving appointments. The tuition for this course is nonrefundable.** Insufficient check fee: \$35.00.
 3. In the event that additional driving time is needed, a rate of \$90.00 for 2 hours will be charged.
 4. Driving appointments for above-named student will be scheduled depending on the availability of Safer Driving School instructors, weather conditions, and subject to all fees being paid in full.
 5. Cancellation of driving **and** testing appointments must be made at least 24 hours before scheduled appointment. **Student will be charged \$75.00 for cancellations not made before the 24-hour period.**
 6. Student and parents or legal guardian will be responsible for any damage to automobile (if not in the ordinary course of driving with instructor), classroom and materials.
 7. Please list **any medical, physical or mental health problems** which could be directly related to student performance in any aspect of the courses to be provided by Safer Driving School (diabetes, epilepsy, amputation, paralysis, deaf or hard of hearing, eye disease or corrective contact lenses, etc.

8. Student has one (1) year from the first day of class to complete driving instruction and road exam. **A reinstatement fee of \$50.00 will be charged for finishing the program after the one (1) year time period.**
9. This contract must be signed by student and parent or legal guardian and turned back into Safer Driving School by the second day of class. **Student will not be able to sign up for driving appointments until contract is received and all fees are paid in full.**

To the extent permitted by law, student and parent or legal guardian agree to indemnify and hold harmless Safer Driving School from any and all damages, expenses, fees, fines or other amounts occasioned by the acts of student at any time. It is acknowledged that this indemnification language is clear, concise and unambiguous and not unduly burdensome. It is also acknowledged that Safer Driving School would not agree to the terms of this Agreement unless such indemnification is granted by student and parent or legal guardian and that the same is an integral part of this Agreement. Safer Driving School is not responsible for the future driving performance of students enrolled in this program.

***Important** – Driving appointments may be scheduled with Safer Driving School depending on availability of Safer Driving School instructors, weather conditions and full payment of all fees. *

What we do for you

We are a State certified driving school. Upon successful completion of our driver education program students will receive a certificate, which may qualify for a reduction on your auto insurance premiums. Please check with your insurance company for the amount of the discount.

Driver Education:

- Classroom instruction completed in 10 hours (consisting of 2 days) at **Safer Driving School** office located in Owasso. You drop your student off at class and pick them up.
- Behind the wheel driving instruction completed in 6 hours (consisting of three, 2 hour drive times). We offer driving times 7 days a week. We will pick up and drop off students on their driving days within our pickup locations and meeting sites. We will meet you in the pickup location to drive your student. You will bring them to that location and pick them up after their lesson. Our State certified driving instructor will pick your student up in a **Safer Driving School** car for their driving sessions. Drive times are scheduled based on student availability, availability of our instructor schedules, and the weather.

The fee for the entire course (10 hrs classroom and 6 hours driving instruction) is \$375. We accept cash, checks, money orders, Visa, MasterCard, and Discover. Due to increasing costs from the credit card company networks, an additional \$5 service charge will be applied to all credit card payments.

Testing Services:

- **Safer Driving School** is certified to administer the Road Skills test for Safer Driving School students, other commercial driving schools, students who have completed a public school driver education program, and online drivers education courses in the state of Oklahoma. Tests are scheduled by appointment only. The total cost for the testing service is \$40 cash. Students will test in a Safer Driving School car.
- **Safer Driving School** also offers a **Prep-driving** lesson. These lessons are scheduled by appointment and done immediately prior to a student's road skills test appointment. The cost is \$40 cash. See our Prices page for our most popular testing package.
- After your student completes the classroom portion of our program, they are eligible to take their written test at the Dept of Public Safety testing site, provided they are at least 15 1/2 years old and they have passed their 8th grading reading test (if they are under age 18). To show proof they have passed that test, they will need a letter from their school on the school's letterhead stating they have passed the 8th grade reading test. **Have your student get the letter from their school as soon as possible!** (especially before students get out of school for break-while the school office is open)

* Skills (Drive) Test - Class D and Motorcycle Beginning November 1, 2017 the Claremore office will be open only on Tuesdays and Thursdays until further notice. This is due to a state wide shortage of personnel.

ATTENTION: Closing times listed don't always reflect when accepting individuals for driver license services will cease. Due to workloads, it may be necessary to cease taking applicants earlier in order to complete processing by the end of the business day. Hours of operation may vary. Some exam sites are staffed with one examiner. Normally for those sites, written testing is done in the morning and scheduled drive tests are conducted in the afternoon. If the examiner is out of the office conducting a drive test, phone calls will not be answered. Calling ahead, preferably in the mornings, is recommended to ensure testing availability.

Need to Know Information for parents and students

Drive times and how to schedule:

Safer Driving School students will have 3, two hour driving sessions. **To schedule those driving sessions, please call or text message 918-779-5204.** Parents or students will need to call or text message Safer Driving School to schedule all driving appointments. You should contact Safer Driving School **at least 4-5 weeks before** you would like to drive so that we can schedule a drive appointment for your student. We will pick-up students up from school or centralized meeting locations including our office and drop off students back off. Driving times depend on student and instructor availability as well as the weather conditions.

Please remember that students will receive a completion certificate on their last driving session. The Safer Driving School certificate is required for students (under age 18) at the time your student takes their driving test. The Dept of Public Safety will ask to see your driver education completion certificate before you can take your driving test.

Drive test services:

Safer Driving School offers convenient drive test services.

Safer Driving School also offers a **Prep** driving lesson. These lessons are scheduled by appointment and are done immediately prior to a student's road skills test appointment. The cost is \$40 cash. Please see our prices page for our most popular testing package.

Graduated drivers license law:

Parents need to know that Oklahoma has a Graduated Drivers License law. There are many important aspects to this law that apply to you and your students.

1. Students will need to have at a minimum, 50 hours of practice driving (10 hours need to be at night) during the time they have their learner's permit. Parents will be required to sign an affidavit at the time of the student's drive test to affirm this.
2. Students (who are under age 18) must have their learner's permit a minimum of 6 months before they can take their drive test and have proof they have completed drivers ed (this proof is their Safer Driving School certificate they get from us on their 3rd driving session)
3. For 6 months after students pass their drive test, the law limits the hours they can drive and the number of friends they can have in their car.
4. Students may only drive between the hours of 5am-10pm unless driving to & from work, church or school or if a licensed driver is seated next to them. Also, students may have only **ONE** friend (passenger) in their car that is under 21 and is not a family member. (This doesn't apply to family members as passengers, only friends-1 friend in the car with them!)
5. Students can not use any type of hand-held electronic device while driving. This includes a cell phone, IPOD/MP3 player, GPS, etc.

Information and documents needed for the written & driving test

For your Learner's Permit

- Students must be at least 15 1/2 years of age or older.
- 2 forms of identification must be provided:
 1. Original birth certificate or passport (see pg. 1-1 & 1-2 of Oklahoma Driver's Manual).
 2. Original social security card (see pg. 1-2 of Oklahoma Driver's Manual).
- Students must have a letter from their school confirming they have successfully passed the 8th Grade Reading Proficiency test and are currently enrolled in school (does not apply to students age 18 & older).
- If test is taken during the summer months, a parent must be present to sign a summer affidavit or an official school letter must have the upcoming school term year to verify school enrollment.
- A parent or legal guardian must be present to sign the "Authorization to Obtain Finger Image" form (if under 18). See last page of Oklahoma Driver's Manual.
- Students must take their copy of their **Safer Driving School** contract for proof of enrollment in driver's education.
- **Written test may be taken at any Dept of Public Safety testing facility.** Appointments can be made at some locations. To schedule an appointment go to www.ok.gov/dps/exam/scheduler.

For your Road Skills test with Safer Driving School

- Students need their learner's permit and social security card as two forms of ID.
- Students must have their copy of **Safer Driving School** completion certificate, which they receive on their last driving session. Green card from public school drivers education program. Embossed certificate from online drivers education program within the state of Oklahoma.
- Student must be at least 16 years of age or older and have had their learners permit for 6 months (if under age 18)
- Must have all fees with Safer Driving School paid in full.

The cost is \$40 for a road skills test, \$25 for the test and \$15 for the use of our car. These tests are scheduled by appointment only.
